# Car Parking

There will be NO vehicles allowed in the Food Court area between 8.30 am & 4.30 pm on Saturday; or between 8.30am & 3.30pm on Sunday.

- Exhibitors must park their Vehicles in the Exhibitors Car Park provided.
- Cars found inside the trade/food areas during the Show, will need to be removed before 8.30am - this is a public safety issue.

# Set Up Dates, Days and Times for the Outdoor Food Court

- 31<sup>st</sup> October 1.00 pm - 6.30 pm Friday
- Saturday 1<sup>st</sup> November 7.00 am - 8.30 am
- Please check in at the office upon your arrival.

# Pack Down Days, Dates and Times:

- 1<sup>st</sup> November Saturday Any time after 4.30pm until 6.00pm
- Sunday 2<sup>nd</sup> November 3.30pm until 5.00 pm
- All Food Sites **must** be cleared by 5.00 pm Monday 3<sup>rd</sup> November

## It is your responsibility to leave your Food Site in the same condition it was in, before your set-up - Please remove ALL rubbish from your site.

# Environmental Health/Food License

- You are required to provide a copy of your Food License (covering the period of the show in November 2024) with your application form. Bookings without a License will not be accepted.
- Each Food Trader/Handler requires its own Health License. You are required to contact the Manawatu District Council AT LEAST 6 WEEKS before our event to apply for any trading permits and licenses. Food Traders will incur a charge to receive the permit.

# TERMS & CONDITIONS

#### Applications

The Manawatu & West Coast A&P Show Association may accept or decline any application.

#### **Payment of Food Site Fees**

• <u>All</u> Food Site fees must be paid in full before arriving at the site.

#### Sub Letting

• Sub-letting will only be permitted at the sole discretion of the Show Administrator and a Fee may be imposed if your request is granted.

#### Show Days

- The show gates will open to the public from 9.00am to 4.30pm.
- Exhibitors/Vendors are expected to have their sites fully operational during the full advertised opening hours of the Show.

#### Exhibits/Sites

- The Food Vendor manager, or any other person appointed by the Manawatu & West Coast A&P Association, has the power to enter an exhibitor's/vendor's site at any time and remove any article, sign, picture or printed matter which in their opinion may cause offence to the public or is not in keeping with the requirements of the Society.
- During the Show, restocking of sites can be done at the beginning or close of the day. No vehicle access will be allowed to the show area between 8.30 am – 4.30 pm on Saturday; or from 8.30am to 3.30pm Sunday.
- The Distribution of any form of promotional material or other forms of marketing outside of the Exhibitor's/Vendor's site boundary is prohibited.
- The Manawatu & West Coast A & P Association will send you the necessary information about which gate is best for you to enter, in relation to your Food Site.
- There will be a security check at intervals throughout the night.
- Any trenching or digging up of the grounds must be put back as it was found by the exhibitor/vendor. Failure to do this will result in an invoice being sent out for any repairs.
- The use of amplifiers or loud speakers by Exhibitors/Vendors is restricted to the extent that it does not affect other Exhibitors/Vendors.
- Camping overnight on your site is at the discretion of the Show Administrator. If you have any questions about what facilities are available, please ask.

#### • Power

- We encourage you to bring your own generator if able for running your van/site.
- Power supply is 240v / 3 point plug. Limited 3 phase may be available.
  Exhibitors requiring power must bring with them an extension lead up to 30 metres long with a current safety certificate. Any Power Lead requiring Safety Inspection on site will be at the exhibitor's expense, and MUST be paid at the time of Inspection.
- Power for Food Sites MUST be requested when booking. Vendors must supply their own extension lead. Single phase power will be charged at \$50 per site; 3 phase power will be charged at \$90 per site.

#### **Insurance and Security**

- The Manawatu & West Coast A & P Association does not insure Exhibitor's/Vendor's property.
- There is regular security Checks done by B&M Security throughout the night.
- The Association will not be liable for loss or damage to the Exhibitor's/Vendor's property while it is on the Show Site.

#### Vehicles

 No vehicles other than Association Service Vehicles are permitted on exhibition/food sites during the Show hours. Cars and Vehicles parked on/near Food sites between 8.30am and 4.30pm must be removed – This is for safety of competitors/visitors throughout the day.

#### Admission and Ticket Allocation

Admission through the gates on Show day requires a **one-day ticket/wristband.** Tickets/wristbands will be posted from the Manawatu & West Coast A & P Association Show Office at least 2 weeks prior to the show, or they can be picked up from the Show office Prior to Saturday. Please arrange this with the office.

#### HEALTH & SAFETY

"The Manawatu A&P Association is required to conform to the **Health and Safety at Work Act 2015**; therefore you are required to carry out your work or undertaking on the Manfeild Park premises to comply with this Act. As a show exhibitor at this venue you are obligated to accept responsibility for ensuring a safe showing venue within the focus of the Act. As a user of these facilities, you are required to manage and supervise all your activities to ensure the good Health and Safety of all people involved in the show, at all times.

#### Food Vendors must be compliant with all Electrical & Gas certification.

- All vehicles, caravans and floats requiring power <u>must</u> have a Warrant of Electrical Fitness that meets current legislation standards.
- Any and all electrical equipment, including extension power leads, must be <u>tested and tagged with</u> <u>a current tag.</u>(Standard AS/NZS3760)
- All vehicles, caravans or floats using gas for heating or cooking <u>must</u> have current Gas Compliance Certificates.
- Vendors must comply with the provisions of the Health & Safety at Work Act 2015 and any subsequent amendments and the Food Act 2014 and any subsequent amendments.
- All Tent and Marquee pegs, spikes or protruding objects must be covered safely.

#### **Advertising and Schedules**

- If you would like any advertising to be included in any Show Promotional material in the Show Catalogues, on the A&P web site or Face Book page, please include this on the application form (with copy, if required).
- Sponsorship opportunities and Corporate Memberships exist for Exhibitors/Vendors and can be negotiated by contacting the Administrator of the Manawatu A&P Show.

#### **Use of Exhibitor Information**

By completing a Food Site Application form the Exhibitor/Vendor agrees and the Manawatu & West Coast A&P Association acknowledges that:

(a) Exhibitor/Vendor information details can be used by the Association for promotional purposes on Facebook and the Associations Website.

#### Cancellation

- The Manawatu & West Coast A&P Association shall not be liable to the Food Vendor for any compensation whatsoever as a result of the cancellation or postponement of the Show. Any refund to Vendors as a result of cancellation or postponement will be at the discretion of the Manawatu & West Coast A&P Association.
- Cancellations must be made in writing Email will be accepted.
  - i. Prior to 20<sup>th</sup> October 2025, the Manawatu & West Coast A & P Association to allow the association time to fill the spot if necessary
  - ii. If on or after 20<sup>th</sup> October 2025, any refund shall be that 30% shall be retained to cover incurred administration costs.
- The Manawatu & West Coast A & P Association has the right to cancel this contract and to retain any monies paid in relation to this contract if the Vendor infringes any of the exhibiting conditions.

#### Animals

 Dogs other than those in organised show activities are not permitted on the Manawatu & West Coast A&P Showgrounds/Manfeild Park Complex.
